1. Applicant who wishes to apply for internship should fulfill the following criteria

1) **Educational Background:** Undergraduate (UG) students such as BE/B. Tech and Postgraduate (PG) students at College/University from Science.

(**Note:** Final year students are not eligible for this internship)

- 2) **Discipline/Major:** Environmental Sciences, Chemical/Environmental Engineering, Environmental Chemistry/Biochemistry, Food Technology or equivalent to environment related discipline.
- 3) Applicant should have scored consistently 75% and above marks throughout.
- 4) Applicant should not have any arrears so far.
- 5) Fluent in English language (Read, Write & Speak).
- 6) Basic computer skills (word, excel, ppt, etc.) are mandatory.
- 7) Selected applicants should be in the position to take leave for two months from their College/University to undergo internship at Hiyoshi Corporation, Japan. Refer **2.ii**)

2. Terms & Conditions of Internship:

i. Scope of Internship

Training in environmental & food sample analysis, and other analysis.

ii. Internship Duration

Two Months (Starting from May 18, 2026, to July 20, 2026).

Note: <u>The internship period from May to July cannot be changed so if you cannot come during this period then please do not apply for the internship.</u>

iii. Internship Expenses:

1) Applicant Responsibility:

- Expenses for Japan Visa Application, Travel and Health Insurance, etc.
- Local travel expenses as follows

(In India from applicant's residence place to the nearest international airport and in Japan from Kansai international airport to Omihachiman city)

2) Company Responsibility:

- Allowances: 80,000 JPY per month will be given to each student.
- Air Ticket: Economy air ticket from the international airport which is nearest to the applicant's residence place to Kansai International Airport, Japan.
- Training related expenses (Uniform and materials needed for the training)



iv. Working Details:

- 1) Working Days and Hours: Monday to Saturday, 08:15-17:15 Hrs. (Lunch break 12:15-13:00 Hrs.)
- 2) Holidays: All Sundays, National holidays if any, two Saturdays in a month
- 3) Training Location: Hiyoshi Corporation, 908 Kitanosho-Cho, Omihachiman, Shiga 523-0806, Japan

v. Accommodation:

- 1) Company dormitory room will be provided free of cost.
- 2) Company dormitory is equipped with Bathtub, Shower, Toilet, Washing Machine, Bed, Kitchen Utensils, Microwave Oven, Refrigerator, TV, Air Conditioner, Water Heater, and Internet.
- 3) Travel: Company will provide bicycle. It takes about 5 10 minutes travel from the dormitory to the company.
- 4) Other conditions: Interns have separate bedroom, but they may share their living space, kitchen and bathroom with roommates.
